

Parkway Center City Middle College Parent and Family Engagement Policy School Year 2019-2020 Revision Date: 04/5/19

In support of strengthening student academic achievement, **Parkway Center City Middle College** receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement policy that contains information required by section 1116(b) and (c) of the Every Student Succeeds Act (ESSA). #### DESCRIPTION OF HOW THE SCHOOL WILL IMPLEMENT REQUIRED SCHOOL PARENT AND FAMILY ENGAGEMENT POLICY COMPONENTS

#### Section A: JOINTLY DEVELOPED

**Parkway Center City Middle College** will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

- Parents are invited to review and provide input on the Parent and Family Engagement Policy and the School-Parent Compact annually during Spring Title I Meeting. This document was reviewed and updated by parents on 4/5/19.

- Feedback from parents is sought in other ways throughout the year, including during regular SAC meetings and via surveys, and parents are invited to participate in the Philadelphia Home and School Council Committees at the district level.

#### Section B: ANNUAL TITLE I MEETING

<u>Parkway Center City Middle College</u> will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent compact.

- Send home pertinent school notices / announcements, calendars, quarterly newsletters providing parents / guardians with important information (including Interim Reports, Parent / Teacher Conferences, important dates and reminders, meetings, School Improvement Strategies, and so on).
- Encourage parents to visit school website often to receive updated information regarding school events, dates, and meetings.
- Translations are available, as needed, through the Family and Community Engagement Office.

- Providing Optional Monthly Family Homework for Students to receive Instant A's from Teachers quarterly reminders to Parents / Guardians on Remind, Google classroom, PCCMC Website.
- Parent Resource Room.

## Section G: BUILDING CAPACITY OF PARENTS

<u>Parkway Center City Middle College</u> will build the parents' capacity for strong parent and family engagement to ensure effective involvement of parents and to support a partnership among the school and the community to improve student academic achievement through the following:

- School District of Philadelphia's Calendar distributed to Students / Parents in School Opening Mailing, on School District's Website (including Important Dates, Testing, Report Card Nights, and so on) and on google group.
- Seasonal school newsletters or notices / announcements (Fall, Winter, Spring) Pennsylvania, School District of Philadelphia, and Parkway Center City Middle College's initiatives.
- Parkway Center City Middle College's dissemination / mailing of SD information regarding Common Core Standards, Assessments, etc.
- Student Interim Reports and Parent / Teacher Conference Afternoons / Nights regarding student progress and suggested improvements.
- Parkway Center City Middle College's initiative regarding parental / guardian involvement, including holding Home and School Elections and forming the School Advisory Council after establishing the Home and School Council.
